## Space Heaters Need Space

**LIKE ANY ELECTRICAL APPLIANCE, PER-**sonal space heaters need their space.

It's especially important to position space heaters at least 3 feet away from anything that could catch on fire. Although the handy appliances come with lots of safety features nowadays, it's still up to you to make sure they don't get close enough to be a danger.

Here's how important that is: The U.S. Consumer Product Safety Commission estimates that more than 25,000 residential fires every year are associated with the use of space heaters, causing more than 300 deaths.

To use a space heater safely, use it wisely. Follow these tips for smart use:

- ▶ Stick with space heaters that carry the mark of UL or another nationally recognized testing laboratory. Those models will offer the most current safety features.
- ▶ Keep all objects, bedding, people and pets at least 3 feet away from the space heater.
- ▶ Replace your space heater if it seems to short out or if its electrical cord is frayed or otherwise damaged.
- ▶ Look for safety features such as automatic shut-off that trips if the device tips over.
- ▶ Place your heater on the floor, not on a stand or a desk, where it could get knocked over.
- ▶ Choose a space heater with a thermostat to avoid overheating the room.

# Lamar Electric To Award \$6,000 in Scholarships

LAMAR ELECTRIC WILL AWARD SIX \$1,000 ACADEMIC SCHOLARSHIPS TO STUDENTS who plan to pursue an academic degree or certification from an accredited university, college, junior college, technical school or other postsecondary educational institution. Scholarship payment will be made directly to the institution in one lump sum and must be used within two years of the award date. Funds may be used for tuition, books, and room and board.

## Eligibility Requirements

To be considered for a Lamar Electric scholarship, a student must:

- ▶ Live full time in a residence served by Lamar Electric.
- ▶ Be a graduating senior attending a high school or an accredited home-school program within the counties served by the cooperative.

Six scholarships will be given away at the Lamar Electric Annual Meeting on April 18 in a random drawing of qualified students. The winners need not be present. Entry deadline is April 3.

# Attention High School Students: Apply Now for Youth Tour

EACH YEAR, LAMAR ELECTRIC COOPERATIVE SELECTS TWO HIGH SCHOOL STUDENTS TO attend the Government-in-Action Youth Tour, an all-expenses-paid trip to Washington, D.C., that includes visiting the U.S. Capitol and meeting members of Congress.



Eligible students must be in 10th, 11th or 12th grade and live full time in a residence served by Lamar Electric or attend one of the three high schools served by the co-op: Prairiland, Detroit and Faith Christian. Home-schooled students served by the co-op are also eligible.

Applications must include a three-page typed essay. The essay topic this year is, “What would life be like without electricity?” The essay must be submitted to Lamar Electric no later than **5 p.m. Friday, February 7.**

### Green Chile Cheddar Cheese Soup

- 4 large baking potatoes
- 1 small onion, chopped
- 4 cans (about 7 cups) chicken or vegetable broth, or 4 bouillon cubes plus water
- 2 teaspoons salt, or less to taste
- 1 cup milk, cream or half-and-half
- 1 can (4 ounces) chopped green chiles
- 1 cup shredded cheddar cheese, plus more for garnish
- Pepper

1. Peel potatoes and chop into medium dice. Put potato and onion in a slow cooker and add broth to cover, reserving remaining broth. You may substitute water and 4 bouillon cubes. Add salt.
  2. Cover and bring to a boil on high, then lower heat and simmer 30 minutes or until potatoes are just tender. Remove half of the potatoes to a colander or bowl. Mash remaining potatoes in cooking broth with a potato masher or spoon. Return reserved potatoes to cooker along with milk, green chiles and cheese.
  3. Let simmer 30–45 additional minutes. Add pepper to taste. If soup is too thick, add extra broth.
  4. Serve with extra shredded cheese, crumbled bacon, sour cream and green onion on top, if desired.
- Serves 6.

# Annual Meeting Set for April 18

**LAMAR ELECTRIC COOPERATIVE WILL HOLD ITS ANNUAL MEETING** at 10 a.m. Saturday, April 18, at the Love Civic Center, 2025 S. Collegiate Drive in Paris. There will be additional information in *Texas Co-op Power* regarding the meeting over the next few months.

Three positions on the board of directors are up for election each year, and this year, districts 1, 8 and 9 will be voting for their directors at the annual meeting. Members residing in districts 1, 8 and 9 who wish to be a candidate for one of the three available board positions must appear in person at the main office of the cooperative and fill out a nomination form between January 19 and February 18, as outlined in the co-op's bylaws. If you are unsure of which district you live in, please refer to the district map, below.

## Lamar Electric Cooperative Bylaws Excerpt

**ARTICLE III. SECTION 3. Qualifications.** No person shall be eligible to become a board member of the cooperative who:

- a) Has not been a member of the Cooperative for at least one year prior to nomination;
- b) Has not been a bona fide resident of the board district for which seeking election for at least one year prior to nomination;
- c) Is any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the cooperative;
- d) Is an employee of this cooperative or has been terminated from the cooperative less than five years;
- e) Is a close relative of an employee or an employee's spouse ("close" being defined as wife, husband, grandparent, grandchild, parent, child, brother, sister, stepparent, stepchild, stepbrother, stepsister, father-in-law, mother-in-law, son-in-law, daughter-in-law, brother-in-law, and/or sister-in-law);
- f) Has been convicted, pleaded guilty or plead "no contest" to a felony; or
- g) Is an incumbent of, or candidate for, an elective public office for which a salary is paid.

No person shall be eligible

to remain a board member who:

- a) Is not a member of the Cooperative;
- b) Is not a bona fide resident of the district for which elected;
- c) Is any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the cooperative;
- d) Is an employee of this cooperative or has been terminated from the cooperative less than five years;
- e) Is a close relative of an employee or an employee's spouse ("close" being defined as wife, husband, grandparent, grandchild, parent, child, brother, sister, stepparent, stepchild, stepbrother, stepsister, father-in-law, mother-in-law, son-in-law, daughter-in-law, brother-in-law, and/or sister-in-law);
- f) Has been convicted, pleaded guilty or plead "no contest" to a felony; or
- g) Is an incumbent of, or candidate for, an elective public office for which a salary is paid.

Upon establishment of the fact that a board member is holding office in violation of any of the foregoing provisions, the board shall remove such board member.

Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the board or at any special or annual meeting of the members.
