

**LAMAR COUNTY ELECTRIC COOPERATIVE ASSOCIATION**  
**PERSONAL APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE**

The undersigned (the "Applicant") hereby applies for membership and agrees to purchase electric service from Lamar County Electric Cooperative Association (the "Cooperative") upon the following terms and conditions:

1. Cooperative agrees to use reasonable diligence to provide electric utility service to a point of delivery at Member's service location. The electric service contracted for therein is to be provided and taken in accordance with the provision of this agreement and Cooperative's rates, policies, rules and regulations. Cooperative does not guarantee that the delivery of electric service will be free from outages, fluctuations or interruptions.
2. The Applicant, by paying a membership fee and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative.
3. Applicant agrees to purchase and pay monthly for electric service in accordance with Cooperative's rates, policies, rules and regulations.
4. The Applicant agrees to comply with and be bound by the provisions of the Articles of Incorporation, Bylaws of the Cooperative, rates, policies and such rules and regulations as may from time to time be adopted by the Cooperative.
5. Upon failure to make payment or perform any obligation under this Agreement the Cooperative shall have the right to discontinue service as well as such remedies as may be provided by law.
6. Applicant warrants that his or her installation (including all conductors, switches, equipment, wiring and protective devices of any kind) is constructed and will be maintained in accordance with the National Electrical Safety Code as published by the Institute of Electrical and Electronics Engineers, Inc. and the National Electrical Code as published by the National Fire Protection Association as well as applicable laws or ordinances.
7. This membership and all rights and privileges thereto shall continue as long as the member purchases electric energy from the Cooperative and complies with the terms and conditions with respect to membership contained in the Bylaws of the Cooperative and any amendments thereto and such rules and regulations as are adopted or modified from time to time by the Cooperative.
